## State Fiscal Year (SFY) Limits Inquiry Process

## Background for the SFY Process

- Historically, Optum has been unable to provide usage of State Fiscal Year (SFY) limits but has
  developed a process to assist providers in checking SFY usage.
- Tribal Health Organizations (THO's) reimbursement is Per Diem. When multiple claim lines are submitted, the per diem rate reimburses on one line. For Non-THO's, Optum's system is built to draw down SFY Units and deny a claim when the units have been exhausted and a Service Authorization is not on file. The Optum claiming system does not deny claim lines 2 or more on THO claims as the per diem rate was paid, not denied. This means the system does not have the ability to draw down SFY unit usage. Without an automated process to draw down and deny for over utilization, Optum has needed to develop a different process to monitor the SFY usage. It is a claims-based system, so data is based on claims submitted.
- Local Optum Clinical team will reach out to THO's to inform you when a participant is at 80% to 100% SFY usage and a service authorization is not on file and needs to be submitted.
- With Service Authorizations going live May 12, 2024, this process will assist providers to not exceed the SFY limits.

- State Fiscal Year Service Limits renew at the beginning of the state fiscal year, which begins 07/01. The state fiscal year ends 06/30 and Optum Service Authorizations will end date on this date.
- Services with a state fiscal year limit: providers do not need to obtain an authorization until
  those limits have been met. A Service Authorization is needed if the provider is requesting an
  extension of services beyond the State Fiscal Year (SFY) limit.

#### Note:

- Providers may not know if the state fiscal year limit has been exceeded so if an authorization is requested and there is evidence of medical necessity, an authorization should be given.
- Utilize the Service Authorization Retroreview process if participant is no longer in treatment, SFY units are exhausted, and a Service Authorization should have been in place during dates of treatment.

3.	Review the Threshold limit	Optum will review for Service Authorization on file.	Daily

If Participant is at 80% of potential threshold and does not have any authorization on file, send communication to provider	When Provider is at 80% of potential threshold, review to see if authorization for additional services is on file.	When Participant is nearing the limit for State Fiscal Year (SFY).

5.	Complete communication and send to providers	<ol> <li>Initial attempt will be via email and if unresponsive with no authorization request, Optum will make a telephonic outreach. 8	. If peer to peer <b>does not</b> meet medical necessity.	Send provider information to DBH for next steps.

As described under 7 AAC 135.040(a)(d):

### **SFY Unit Usage – Facility Inquiry to Optum**

Previously, Optum was unable to inform providers of the SFY unit usage for participants. But we now have a new process for providers who want to ask Optum about SFY unit usage.

#### Process:

- Providers will go to the <u>Alaska Optum Provider Portal</u> and complete the request form
- Providers will send a request on the fillable form via their secure email delivery system to Optum
- Request is received in the <u>SA\_and\_ClinicalRecords@optum.com</u> mailbox managed by the Utilization Management team.
- UM Manager reviews the request, fills in the information and returns to Provider via email utilizing secure email delivery.
- Timeframe for response to providers:

Same day prior to 4:00 PM

After 4:00 PM, Next day

If after 4:00 PM on Friday, weekend or holiday, Next business day



## **Next Steps**

 Obtain a list of facility contacts for the THO's, and method preferred for contact (i.e., email, phone, mail, etc.). Optum needs a primary and secondary contact name and method of contact.

## Real Time Scenarios from Director Training on 4-17-24

- Email Provider, phone call, also point of contact have all the communication come to one email: yes, if a group email.
- Utilization thresholds: participant is at 79% and then send claims a month at a time and gets to 96% utilization. Window of time to get authorization approved. Process same for all. UM Manager (Korey) could do a courtesy reach out to provider.
- Receiving services from organizations: How is that reconciled? Report shows all providers utilizing the services. What if multiple agencies are billing the same code? If active in treatment, notify all providers.
- Distribution list to update email Optum.
- What if we want to check the SFY? Where will the form be? On the Optum Alaska website.
