SFY 2024 – DBH Guidance Document #1

Guidance Document for suspension of Service Authorizations for Specific Services listed below

Service Authorizations for Provider Types:

- Autism Services
- Community Behavioral Health Providers
- Mental Health Physician Clinics

On July 31, 2023 Centers of Medicare & Medicaid (CMS) approved an extension of the Alaska Disaster State Plan. This order suspends all Service Authorization requirements outlined in 7 AAC 135.040. The impact for providers will be as follows:

Effective May 12, 2023 providers are no longer required to submit Service Authorizations for the services outlined below. *This suspension of Service Authorizations is effective May* 12, 2023 through May 11, 2024.

For providers who currently have recipients in services with a service authorization in place, those authorizations are now suspended, and no further service authorization request are required. Service authorizations are suspended for services below including services with XE, XU, XP, GT, 95, and FQ modifiers.

However, providers MUST do the following:

- Ensure the services provided are Medically Necessary and meet all requirements as outlined in 7 AAC 135.100 – 7 AAC 135.350
- Document the need for services in both the assessment and treatment plan
- Document the services in a progress note that indicates the medical necessity
- Continue to submit service authorization requests for 1115 substance use disorder (SUD) and 1115 behavioral health (BH) waiver services
