Service Authorization Cluster Guidance May 15, 2023

Service Authorization Clusters are a grouping of service codes that can be on one service authorization, sharing one authorization number. Only one service authorization form will need to be submitted. However, there is a possibility that due to service authorization clusters, more than one service authorization number will be issued per service authorization request form. Below, is the list of clusters, including the cluster name and the service codes associated with that cluster.
